Formula and baby foods for infants are to be provided by the parent(s) as well as child (ren) with special diets. It is the Parent(s) responsibility to provide lunch or breakfast for their child(ren) if he/she arrives at the childcare after a mealtime **NO FOOD** will be served after a designated mealtime. Please consume all food outside the facility before arrival and do not bring candy or gum. The provider will serve breakfast from 7:20 a.m. – 7:50 a.m. and Lunch will be served from 11:20 a.m. - 11:50 a.m.

- All cancellations must be received by 2:00 p.m. the day prior to reservation. If reservation has not been cancel full payment will be expected for breach of contract.
- Forms required on the first day of enrollment (Drop in only) Contract, Permission form and copy of immunization records.
- Symptoms and illness-required removal from childcare setting fever, diarrhea, vomiting, body rash, soar throat, swollen glands, server coughing, eye discharge, yellow skin or eyes, irritable and continuously crying.
- Tuition payments are to be paid on each morning in the form of cash, check, and money order. Children that are not picked up within reason will be in the care of Child Protection Services (301) 909 -2450. Any child (ren) that is picked up after 6:00 p.m. will accrue a late fee \$2.00 per minute. The parent(s) will be liable for any and all collection cost. All accounts that are past due will not exceed past (1) week.
